ASSESSMENT

Monthly assessments are conducted and progress reports are issued accordingly.

These courses are designed to prepare international students for admission to mainstream primary and secondary schools in Singapore. Students are taught English and Mathematics subjects in preparation for the Admissions Exercise for International Students (AEIS) and Supplementary AEIS (S-AEIS) examinations. Students who are successful in the AEIS or S-AEIS exams will receive a school posting offer from the Singapore Ministry of Education.

EDUCATIONAL PATHWAY

After completing the course, students will sit for the AEIS or the S-AEIS examinations to gain admission to government schools.

ADMISSION REQUIREMENTS

PRIMARY 2 & PRIMARY 3**

- Aged between 7 and 9+ years old* (for P2) OR 8 and 10+ years old* (for P3)
- Completed at least Year 1 (for P2) OR Year 2 (for P3) or its equivalent

PRIMARY 4 & PRIMARY 5**

- Aged between 9 and 11+ years old* (for P4) OR 10 and 12+ years old* (for P5)
- Completed at least Year 3 (for P4) OR Year 4 (for P5) or its equivalent

SECONDARY 1

- Aged between 12 and 14+ years old*
- Completed at least Year 6 or its equivalent

SECONDARY 2

- Aged between 13 and 15+ years old*
- Completed at least Year 7 or its equivalent

SECONDARY 3

- Aged between 14 and 16+ years old*
- Completed at least Year 8 or its equivalent

* Age requirement must be met as of 1st January of the intended academic year of admission into the government school.

** Students must pass the relevant Cambridge English Qualifications (CEQ) test in order to qualify for registration into the AEIS/S-AEIS exams. Those who have not passed the CEQ will need to register for the Certificate in General English (CGE) course to prepare for the CEQ test and pass at the required level at least 3 months prior to the intended AEIS/S-AEIS exam date.

ATTENDANCE REQUIREMENT

The Immigration and Checkpoints Authority requires Student's Pass holders to maintain an attendance of at least 90%. Students who attended at least 75% of lessons are eligible for a Certificate of Attendance.

DISCLAIMER

The Admissions Exercise for International Students (AEIS) and the Supplementary Admissions Exercise for International Students (S-AEIS) are centralised admission examinations conducted by the Ministry of Education (MOE) for foreign students who wish to join the mainstream primary and secondary schools.

The posting of a student is based on the student's test performance, availability of school vacancies and the student's intended residential address in Singapore.

The MOE does not normally accept any school choice requests, release test scores or accept school transfer requests.

While we do our best to prepare students for the AEIS and S-AEIS exams, we cannot guarantee successful admission.

This course prepares students for the Singapore-Cambridge GCE (Ordinary Level) examinations. GCE 'O' Level is the entry requirement for admission to the prestigious Junior Colleges and Polytechnics in Singapore. GCE 'O' Level is also a highly regarded qualification for entry into various foundation courses in USA, UK, Australia, Canada, New Zealand, and many other countries. We recommend students take 7 subjects if they are taking this examination for the first time.

EDUCATIONAL PATHWAY

A GCE 'O' Level Certificate with 6 'O' Level passes (including English Language) would enable students to meet the general academic entry requirements of many Junior Colleges, Polytechnics, Institute of Technical Education, Diploma, and other equivalent institutions not only in Singapore but also in the United Kingdom, Australia, Canada, USA, and New Zealand. Admission into these institutions is at the sole discretion of the individual institutions.

- 15 years old as of 1st January of the examination year

- Completed at least Year 9 or its equivalent OR completed at least Year 8 or its equivalent for enrolment into the Extended course

Qualification awarded by Ministry of Education, Singapore & University of Cambridge International Examinations



This course prepares students for the Singapore-Cambridge GCE (Advanced Level) examinations. The GCE 'A' Level is a widely acclaimed and recognised qualification that is accepted for admission to bachelor's degrees across the world, including the prestigious and top-ranked universities in Singapore, Australia, Canada, New Zealand, United Kingdom, United States and Europe.

EDUCATIONAL PATHWAY

Students who score well for the GCE 'A' Level examinations may apply to the various public universities in Singapore (NUS, NTU, SMU, SUTD). National University of Singapore (NUS) and Nanyang Technological University (NTU) are now ranked 12th and 13th in the world and 1st and 2nd in Asia (QS 2015/2016) respectively. Admission into these institutions is at the sole discretion of the individual institutions.

Alternatively, students can progress on to SSTC's degree pathways through the Pearson BTEC Level 5 HND Diploma programmes or the Advanced Diploma in Commerce and Liberal Arts.

- 17 years old as of 1st January of the examination year

ACADEMIC

- Completed at least Year 11 or its equivalent OR completed at least Year 10 or its equivalent for enrolment into the 24-month course

- International students are strongly advised to have an English language proficiency equivalent to IELTS/TOEFL iBT score of 6.0/80


